Edward Daniel Goodliffe, 34, clerk, pleaded "Guilty" to emberzing large sums of money, belonging to Messrs, Midlane and Uo.; also to falsifying the accounts and books of the firm.

Mr. FORREST FULTON presented, and stated that the prisoner had been engaged as managing clerk to the prosecutors. Although the sums he was charged with embezzling amounted to only £481, the sum he had actually taken was considerably more. The case was aggravated by the fact that the prisoner had very extensively falsified the books of the firm.

Mr. Ernest Beard addressed the Court for the prisoner, who was sentenced by the Recorder to five years' penal servitude.
